All production is outsourced to our solid network of CMOs and pre-wholesalers/distributors. We aim to establish long-lasting relationships with our partners and expand our global network to ensure that our products are available to a large number of patients and healthcare professionals all over the world.

ENVIRONMENT

Never have environmental challenges been more critical and urgent than today. Sustainability of the environment we live in and the health of the people around the world are threatened by growing consumption and industrialization. Some of the biggest environmental challenges are climate change, water resources, plastic waste, and pollution.

At Macure Pharma we aim to constantly reduce the environmental impact of our operations, as the well-being of the planet is an important part of a healthier tomorrow in line with the Paris Agreement. We have therefore identified our key focus areas that are incorporated into our business strategy and operations, as we seek to foster environmental awareness and responsibility among our employees, customers, and partners.

ENERGY CONSUMPTION

In Macure Pharma we aim at reducing energy consumption and ensuring a transition toward renewable electricity. We have outsourced all manufacturing to our partners and CMO's, whom we encourage to be ambitious in the journey of eliminating the environmental footprint of production.

On a regular basis, we collect data on energy consumption from our primary manufacturers to monitor the energy consumption used per produced unit and the development in use of electricity from a green energy source. It is important for us to see a positive development to ensure we and our manufacturers are heading toward the goal of reducing our environmental impact.

WATER CONSUMPTION

Water consumption is a key focus area for Macure Pharma. Our aim is that water consumption is reduced to the level where there is no waste of water in production. We ensure that all manufacturers have processes in place for wastewater management and that chemical wastewater is treated in compliance with local as well as global standards and limit values and monitor the development in use of water and disposal of wastewater from our main manufacturers. We do this by encouraging our manufacturers to commit to continuously optimizing operations and reusing water whenever possible.

CO2 EMISSION

Macure Pharma is a global company operating with suppliers and customers all over the world. Our supply chain accounts for the majority of our total CO2 emissions, and our focus is therefore beyond our own operations when considering our environmental impact.



To reduce our footprint, we work with carriers who engage in protecting the environment and make smart choices in ways of transporting medicines. We primarily use vehicles, and we ensure that they are approved according to EURO-6 standards and preferably ISO 14001:2015 certified.

WASTE MANAGEMENT

At Macure Pharma we acknowledge the potential harm that chemicals and toxic substances from the production of pharmaceuticals can cause to the environment. We therefore ensure that our manufacturers identify potential impact of waste products and that they have processes in place to handle waste accordingly to avoid any harm on the environment.

Minimizing waste and increasing recyclability is a core focus at Macure Pharma. Our focus is that the packaging material of our products are recyclable, and we work with our suppliers to continuously improve our portfolio of products.
